terms and conditions – digital portrait photography

Sitting fee

A sitting fee is payable at the time of booking, to secure your photo session. This can be paid by cheque, cash, bank transfer or electronically via the PayPal website.

Cancellation and re-booking

The sitting fee is non-refundable in the event that you cancel your booking less than 48 hours before your session. If you have booked an outdoor shoot and prevailing weather conditions mean that the shoot cannot take place (for example because the chosen location is unsafe or inaccessible), the photographer may suggest an alternative location, or re-book your shoot for the earliest mutually convenient date. In the event that the photographer has to cancel your shoot due to other circumstances outside his control, such as illness, every effort will be made to reschedule the shoot, but you will be given the option to cancel your session, in which case the sitting fee will be refunded, but Russell Harper Photography (RHP) will have no further liability in respect of this agreement.

Image manipulation

Digital images are individually processed. Minor retouching is a part of the service offered, but the significant alteration of images may incur an additional charge based on time taken. In this case, costs will be agreed prior to the commencement of any retouching work.

Viewing your pictures

Depending on your circumstances and requirements, the photographer will present your digital images to you in person and/or make them available for viewing via an online gallery, which will be password-protected.

Products and pricing

RHP will offer a range of photographic products. RHP's standard price list is adjusted periodically, and orders will be charged at the prices in effect at the time the order is placed. Special offers may be made available from time to time at the discretion of RHP, and any such offers may be withdrawn at any time without notice.

Ownership, copyright and reproduction of photographic images

Pictures are supplied on loan, and no ownership or reproduction rights pass to the Client unless requested by the Client and confirmed in writing by RHP. This means that images created by RHP may not be copied, scanned or otherwise reproduced by any person or machine other than the photographer or their appointed agents. The sole exception to this is that where images are supplied to the client

electronically (for example by e-mail or on a digital storage medium) when the client may make unlimited reproductions for their own personal use, but the client is not entitled to alter or manipulate the images in any way. No images supplied by RHP may be used for any commercial purpose, including advertising and any other promotional purpose, without the express written permission of RHP.

Use of images by RHP

RHP reserves the right to use a Client's images for advertising and promotion of RHP in various media (include RHP's own website), entry in photographic contests or art exhibitions, editorial use, for the creation of samples, or for display within or on the outside of any studio used by the photographer. No names or any other identifying information will be disclosed by RHP when using images for these purposes. If you wish to restrict the use of your images in any way, please advise RHP in writing or by e-mail to mail@harperphotography.co.uk.

If RHP wishes to use any of your images for commercial purposes where payment is sought or received, such as the sale of images to photographic libraries, RHP will not do so without first obtaining your written permission.
